John Mruskovic – President

Welcome everyone!

Call to order at 10:06 am. Pledge of Allegiance and New Mexico flag was recited.

All BOD and Officers are present, with the exception of John and Anne Exterkamp. Let us go ahead and get started. Can we get a motion to approve the minutes without reading them from 2024? Janet Petty motioned and Dauna Mruskovic second. Minutes approved. John and Anne are not here so Janet will read their reports. We will start us off with financials.

Anne Exterkamp — Treasurer — Report read by Janet Pettu

Financial Reports

Balance Sheet – Account 124 is for lot 154 owned by HOA. We are asking \$19,000 for the 30 acres that we Foreclosed on (no other auction bidders).

Profit & Loss (budget) - Refer to the 2nd and 3rd columns for the Year-to-Date numbers. Recovery accounts 410 through 413 for \$1,615 due to paid off accounts.

Fraudulent Checks were created using our bank name, our HOA name and previous checking account number. Our WaFd banker transferred all funds to a new account after the first check posted. Seven fake checks for \$1,650 to \$30,000 posted from March through June. All checks were returned and NO LOSS to the HOA. A business owner questioned the validity of the 8th check and stopped his "sale" of a \$13,900 trailer.

2025 Lincoln County delinquent property tax auction was cancelled for the second year due to Ruidoso fires/floods. We could have had 8 parcels in the public auctions.

2026 Annual Regular Assessment is \$235 with \$10 discount for early payment. First increase since 2009. Approved by the Board on 01/18/2025.

July 2025 Newsletter announcement. the Balance Sheet, the banking accounts balances were reviewed. On the Profit & Loss Budget Performance report, Anne stated that our Operating Costs continue to rise. Our General Liability insurance increased \$300 a month to \$1,337. Janet is working with our agent to get the cost down. The participants would refer to the Balance Sheet report and the Profit & Loss report when the Directors are discussing their responsibility.

John Exterkamp — Director — Report read by Janet Petty

Delinquencies & Collection Report

Delinquent Accounts – 26 parcels owned by 21 people

Total Amount Due \$10,966.55. Amount won't match Balance Sheet #115 Accounts Receivables due to overpayments.

All collection costs and legal fees are charged to the lot owner.

Liens recorded on balances over \$400 (public notice of HOA debt)

Legal Action of a Complaint for Foreclosure -- 3 lots at \$4,196. More than \$1,000 owed -- Board members approve the Pending Legal Action letter to be sent by Restricted Certified Delivery (lot owner must sign for the envelope)

Attorney Fees increased – Profit & Loss Budget was not adjusted for August through December. Attorney hourly rate now \$270 (up 12%) and Legal Assistant hourly rate \$80

John Mruskovic – President – Road Report

First let me thank the "road crew" Tim Taylor, Ron Clawson, JP Linkous, Waddy Hobbs and Sue Perney. Digging ditches moving culverts and grading the road among other things. Here is a list of just a few of the projects being worked on:

- 1. Windmill Road
 - a. roller used to crush and compact large rocks.
- 2. Ranchview Loop, Camp, Stirrup, Chaps, Fenceline and Horseshoe
 - a. roller used to crush and compact large rocks
- 5. North side of Windmill
 - a. gravel added
 - b. roller used to crush and compact large rocks

Approximately 2,000 tons of gravel was added to the roads.

Total budget for 2025 road work -\$152,000.

Spent from January to August 15 - \$39,694.

Left in budget for road work - \$112,305.



Waddy Hobbs – Rancher – Report

Early spring rain started us off and never really stopped. We got some serious downpours that took out some roads, but the grass is up to my elbows, and the cows are fat and happy. We have about 220 head. Please drive carefully and slow down; calves have a way of jumping in front of cars. Cows have the right of way on the ranch, and no one wants to have an accident.



Janet Petty - Secretary - Report

Dumpsters: We now have 5 dumpsters. Please continue to break down boxes and bag your trash. Breaking down boxes allows your neighbors room to dump their trash. Kindness only takes a minute. Please close the lids after dumping to keep trash in the dumpster.

BOD meeting was held on October 5, 2025.

Call to order 1:30 pm by John Mruskovic

Motion was made by John Mruskovic to appoint Anne Exterkamp Treasurer and was seconded by Tim Taylor. All board members agreed and Anne accepted.

Motion was made by John Mruskovic to appoint Janet Petty as Secretary and was seconded by Bob Petty. All board members agreed and Janet accepted.

Motion was made by Bob Petty to not raise assessment fees and was seconded by John Holt. BOD agreed fully there was no reason to increase assessment fees for the 2026; fees would stay at \$235.

It was agreed by all that the HOA will still offer the \$10 discount for those who pay their assessment by 1/31/26.

It was agreed by all that the BOD would remain in the same positions.

It was agreed by all that road repair was a priority for the ranch.

John Holt agreed to continue maintaining website.

John Mruskovic asked if there was any other business? No.

Bob Petty moved to close business and Tim Taylor seconded.

Meeting adjourned 1:45 p.m.
